

By Law, Massachusetts Dealers Must Offer an Express Warranty on All Used Vehicles.

Chapter 90, Section 7N1/4 of Massachusetts General Laws requires an automobile dealer to provide a warranty covering certain classes of used motor Vehicles.

The Vehicle You have purchased may be covered by this law. If so, the following is added to this Service Contract:

In addition to the dealer warranty required by this law, You have elected to purchase this Service Contract, which may provide You with additional protection during the dealer warranty period. Further, if the Plan Period is longer than the required dealer warranty period, this Service Contract will provide protection after the dealer warranty has expired. You have been charged separately only for this Service Contract. The required dealer warranty is provided free of charge. Furthermore, the terms stated in the Definitions, Plan Coverage and What Is Not Covered sections of this Service Contract apply only to this Service Contract and are not the terms of the required dealer warranty.

Exclusions

Remember that the used car you sell might not be covered by the used car warranty law. The following cars are excluded from the law

- Cars with 200,000 miles or more
- Cars sold for less than \$3,000 (except for those cars between 75,000 and 200,000 miles entitled to a 15 day or 500-mile warranty under subdivision 2(a)(3))
- Custom-built cars, or cars modified for show or racing
- Cars purchased primarily for business or agricultural use

- Cars that are eight years of age or older (except for those cars between 75,000 and 200,000 miles entitled to a 15 day or 500-mile warranty under subdivision 2(a)(3))
- Vehicles with a gross vehicle weight of more than 9,000 lbs.
- Vehicles manufactured in limited quantities
- Vehicles not manufactured in accordance with federal emission standards
- Diesel engine vehicles
- Salvaged vehicles.
