

#### Illinois dealers must offer implied warranty on used cars.

Illinois law requires dealers to extend an implied Warranty on most used vehicles for 15 days or 500 miles, whichever occurs first.

The coverage concerns power train components only. The law does not apply to vehicles with more than 150,000 miles at the time of sale, or to vehicles that have been branded "rebuilt" or "flood."

A dealer's maximum liability for repairs under the law is limited to the purchase price paid for the used vehicle, to be refunded to the consumer in exchange for the vehicle.

On the Buyer's Guide, the "As Is" box would be checked when selling vehicles affected by the new law, but related paperwork must carry the following statement in boldface 10-point type or larger, set off from the body of the agreement:

"Illinois law requires that this vehicle will be free of a defect in a power train component for 15 days of 500 miles after delivery, whichever is earlier, except with regard to particular defects disclosed on the first page of this agreement. "Power train component" means the engine block, head, all internal engine parts, oil pan and gaskets, water pump, intake manifold,

transmission, and all internal transmission parts, torque converter, drive shaft, universal joints, rear axle and all rear axle internal parts, and rear wheel bearings. You (the consumer) will have to pay up to \$100 for each of the first 2 repairs if the warranty is violated."

The warranty does not extend to damage that occurs as a result of off road use, racing, towing, abuse and other negligence.

#### **Exclusions**

Remember that the used car you sell might not be covered by the used car warranty law. The following cars are excluded from the law

- · Cars with 200,000 miles or more
- Cars sold for less than \$3,000 (except for those cars between 75,000 and 200,000 miles entitled to a 15 day or 500-mile warranty under subdivision 2(a)(3))
- Custom-built cars, or cars modified for show or racing
- Cars purchased primarily for business or agricultural use

- Cars that are eight years of age or older (except for those cars between 75,000 and 200.000 miles entitled to a 15 day or 500-mile warranty under subdivision 2(a)(3))
- Vehicles with a gross vehicle weight of more than 9,000 lbs.
- · Vehicles manufactured in limited quantities
- Vehicles not manufactured in accordance with federal emission standards
- Diesel engine vehicles
- Salvaged vehicles.
